5. Function Specifications

5.1. Authority Check

- (1) The user shall be registered in the system.
- (2) When the declaration No. is entered, the user must be the same user, who entered data element registration, or the planned declarant.
- (3) When the Export control No. is entered, it shall be the same as the customs broker, for whom Sea cargo information is registered, or as the planned declarant registered in Sea cargo information.
- (4) When the AWB No. is entered, when Export air cargo information is registered and when the customs clearance trustee is specified, it shall be the same as that of the user of the customs clearance trustee.
- (5) When the Electronic invoice receipt No. is entered, it shall be either of the following A or B:
 - (A) The input user shall be either of the following:
 - The customs broker who is registered in Invoice packing list information
 - The input user of IVA service who is registered in Invoice packing list information
 - (B) The first 10 digits of the exporter code that is registered in the Invoice packing list information shall be the same as the first 10 digits of the exporter code that is registered in the User information of input user.
